- Be proactive in the improvement of transportation and mobility through road maintenance and adjustment projects that are supported with adequate yet attentive budgeting. Implementing a Major Thoroughfare Plan and begin to budget for Capital Improvement projects. Funding can be created through numerous creative ways.
